ORDER:-

In the Government Order first read above, orders were issued, re-grouping the Municipalities Under the Jurisdiction of the 7 Regions of Municipal Administration. The Commissioner of Municipal Administration in his letter second read above, has pointed out that as per existing orders 19 Municipalities are under the control of Regional Director of Municipal Administration, Chengalpattu and only 3 Municipalities are under the control of Regional Director of Municipal Administration, Vellore as mentioned below:-

2. In order to have better progress in Municipal works in Villupuram and Tindivanam Municipalities, the Commissioner of Municipal Administration has requested to transfer the above two Municipalities from the jurisdiction of the Chengalpattu Region to the jurisdiction of the Vellore Region.

3. The Government, after careful examination, accept the proposal of the Commissioner of Municipal Administration. They accordingly direct that Villupuram and Tindivanam Municipalities in the Villupuram Ramasamy Padayachiar District be transferred from the administrative control of the Regional Director of Municipal Administration, Chengalpattu to the administrative control of the Regional Director of Municipal Administration, Vellore.

4. The above order shall come into force with immediate effect.
