ORDER:

In the Government Order first read above, the Government sanctioned an ad-hoc increase in the Honorarium/Consolidated Pay of various categories of employees with effect from 1-7-2008.

2. In the Government Order second read above, orders were issued enhancing the Dearness Allowance payable to Government employees on regular time scale of pay/non-standard (special) time scale of pay with effect from 1-1-2009. Government has therefore, decided to grant ad-hoc increase to those drawing Honorarium/Consolidated Pay at certain rates which were in vogue before 1-1-1996. Accordingly, Government direct that employees drawing Honorarium / Consolidated Pay be allowed another ad-hoc increase with effect from 1-1-2009 as detailed below:-

For those drawing Rs.150/- and above Rs.20/- per month

per month prior to 1-1-1996

For those drawing below Rs.150/- per Rs.10/- per month

month prior to 1-1-1996

- **3.** The payment of arrears of adhoc increase for the months of January and February, 2009 shall not be made before the date of disbursement of Honorarium / Consolidated pay of March, 2009.
- **4.** This order shall also apply to employees of Local Bodies, Over head tank operators and Sweepers working in Rural Development and Panchayat Raj Department.
