### NOTIFICATION

In exercise of the powers conferred by section 303 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), section 347 of the Chennai City Municipal Corporation Act, 1919 (Tamil Nadu Act IV of 1919), section 431 of the Madurai City Municipal Corporation Act, 1971 (Tamil Nadu Act 15 of 1971), section 430 of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981), section 8 of the Tiruchirappalli City Municipal Corporation Act, 1994 (Tamil Nadu Act 27 of 1994), section 8 of the Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 23 of 1994) and section 8 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Town Panchayats, Municipalities and Corporations (Delimitations of Wards or Divisions and Reservation) Rules, 199

### AMENDMENTS

In the said Rules, -

(i) in rule 4, after sub-rule (3), the following sub-rule shall be added, namely:-

"(4) The reservations made for Scheduled Castes and Scheduled Tribes and Women belonging to Scheduled Castes and Scheduled Tribes and women in general with reference to sub-rules (1) to (3) above shall be in vogue for two full terms of the council, namely ten years, and rotated thereafter at every ten years interval based on the next higher percentage of population of respective groups "

(ii) In rule 5, the following paragraph shall be added at the end  
namely:-

"The reservation so made shall be followed for two full terms of the  
terms of Chairman of Town Panchayats and Municipalities and the Mayor  
Corporations; namely ten years, and rotated thereafter at every ten  
years interval based on the next higher percentage of population of  
respective groups."
