NOTIFICATION.

In exercise of the powers conferred by sections 3-H, sub-section (3) of section 12, 23, 23-A, 43-C, 73, 303 of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), sections 6-A, 6-G, 29, sub-section (1) of section 59, sections 85, 347 of the Chennai City Municipal Corporation Act, 1919 (Tamil Nadu Act IV of 1919), sections 6, 10-B, 30, 66, clause (c) of sub-section (3) of section 104, section 431 of the Madurai City Municipal Corporation Act, 1971 (Tamil Nadu Act 15 of 1971), sections 6, 10-B, 30, 68, clause (c) of sub-section (2) of section 106, section 430 of the Coimbatore City Municipal Corporation Act, 1981 (Tamil Nadu Act 25 of 1981), read with section 8 of the Tiruchirapalli City Municipal Corporation Act, 1994 (Tamil Nadu Act 27 of 1994), section 8 of the Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 28 of 1994) and section 8 of the Salem City Municipal Corporation Act, 1994 (Tamil Nadu Act 29 of 1994) and in consultation with the Tamil Nadu State Election Commission, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Third Grade Municipalities and Municipal and Corporation Councils (Elections) Rules, 1996, the same having been previously published as required under clause (a) of section 348 of the said Tamil Nadu Act IV of 1919, so far as the Chennai City Municipal Corporation is concerned.

AMENDMENT.

In the said Rules, in rule 75, to sub-rule (6), before the Explanation, the following proviso shall be inserted, namely:-

"Provided that this sub-rule shall not apply, if the process of election could not be started at three consecutive meetings for want of such majority."
