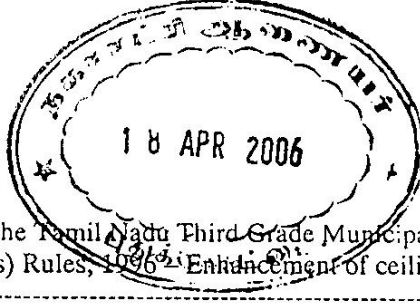

APPENDIX

In exercise of the powers conferred by section 303 of the Tamil Nadu District Municipalities Act 1920 (Tamil Nadu Act V of 1920), section 347 of the Chennai City Municipal Corporation Act 1919 (Tamil Nadu Act IV of 1919), section 431 of the Madurai City Municipal Corporation Act 1971 (Tamil Nadu Act 15 of 1971), section 430 of the Coimbatore City Municipal Corporation Act 1981 (Tamil Nadu Act 25 of 1981), read with section 8 of the Tiruchirapalli City Municipal Corporation Act, 1994 (Tamil Nadu Act 27 of 1994), section 8 of the Tirunelveli City Municipal Corporation Act, 1994 (Tamil Nadu Act 28 of 1994) and section 8

of the Salem City Municipal Corporation Act 1994 (Tamil Nadu Act 29 of 1994), the Governor of Tamil Nadu in consultation with the Tamil Nadu State Election Commission, hereby makes the following amendment to the Tamil Nadu Third Grade Municipalities and Municipal and Corporation Councils (Elections) Rules 1996, the draft of the same having been previously published as required under clause (a) of section 348 of the said Tamil Nadu Act IV of 1919, in so far as the Chennai City Municipal Corporation is concerned.

AMENDMENT

In the said Rules, in rule 93, for sub-rule (1), the following sub-rule shall be substituted namely:-

(1) The total expenditure which can be incurred or authorized in connection with an election under these rules shall not exceed the amount mentioned below:-

(a) for election as Councillor of a Third Grade Municipality	7,500
(b) for election as Chairman of a Third Grade Municipality	37,500
(c) for election as Councillor of a Municipality (Second and First Grades)	15,000
(d) for election as Chairman of a Municipality (Second and first Grades)	75,000
(e) for election as Councillor of a Municipality (Selection and Special Grades)	37,500
(f) for election as Chairman of a Municipality (Selection and Special Grades)	1,50,000
(g) for election as Councillor of a Corporation (other than Corporation of Chennai)	22,500
(h) for election as Councillor of Corporation of Chennai	37,500
(i) for election as Mayor of a Corporation (other than Corporation of Chennai)	3,75,000
(j) for election as Mayor of Corporation of Chennai	7,50,000
