**Delimitation of Wards / Divisions of Town Panchayats, Municipalities and Corporations - Notified for the election of Urban Local Bodies held in 1996 - Continuance of existing territorial area of wards and the boundaries of Urban Local Bodies - Orders - Issued.**

### ORDER :

In the Municipal Corporations of Chennai, Madurai and Coimbatore, the strength of Councillors to be elected to the Councils, is prescribed in the Acts applicable to the respective Corporations. However, in the case of other Corporations viz., Tiruchirapalli, Salem and Tirunelveli, the Government in the G.O. first read above, have determined and notified the strength of the councils.

In respect of Municipalities, the Government in their G.O. second read above, have prescribed the number of Councillors to each of the Municipal Councils.

3. In the case of Town Panchayats, the Government have prescribed the scale for fixation of the number of Councillors to be elected by each of the Town Panchayats by the Inspector of Town Panchayats. Accordingly, the Director of Town Panchayats had notified the strength of councils of Town Panchayats.

4. Based on the strength of the councils fixed, Commissioners of Corporations, Commissioner of Municipal Administration and Director of Town Panchayats have delimited the respective Urban Local Bodies areas into wards / Divisions and notified the territorial areas of the wards / Divisions of the councils.

5. In connection with the Urban Local Body elections to be held in 2001, the Government have decided that there will be no change in the territorial area of the wards in local bodies and the boundaries of the local bodies from the one that is existing as on date.

6. The Commissioner of Municipal Administration, Director of Town Panchayats and the Commissioners of Corporations are directed to take action accordingly.
