## ORDER:

the Municipal Corporations of Chennal, Madural and Coimbatore, the strength of Councillors to be elected to the Councils, is prescribed in the Acts applicable to the respective Corporations. However, in the case of other Corporations viz., Tiruchirapalli, Salem and Tirunelveli, the Government in the G.O. first read above, have determined and notified the strength of the councils.

In respect of Municipalities, the Government in their G.O. second read at ove, have prescribed the number of Councillors to each of the Municipal Councillors.

3. In the case of Town Panchayats, the Government have prescribed the scale for fixation of the number of Councillors to be elected by each of the Town Panchayats by the Inspector of Town Panchayats. Accordingly, the Director of Town Panchayats had notified the strength of councils of Town Panchayats.

- 4. Pased on the strength of the councils fixed, Commissioners of Corporations, Commissioner of Municipal Administration and Director of Town Par chayats have delimited the respective Urban Local Bodies areas into wards / Divisions and notified the territorial areas of the wards / Divisions of the councils.
- 5. In connection with the Urban Local Body elections to be held in 20(1), the Government have decided that there will be no change in the territorial are a of the wards in local bodies and the boundaries of the local bodies from the one that is existing as on date.
- 6. The Commissioner of Municipal Administration, Director of Town Panchayats and the Commissioner of Corporations are directed to take action accordingly.
