The next General revision of property tax in respect of the following Municipalities and Mettur Township is to be taken with effect from 1-4-1974.

2. The Director of Municipal Administration, Madras, has stated that as Municipal elections are expected to be conducted by the month of April 1974 and as the Municipal staff are fully engaged in election work, it will be difficult to take up the work relating to revision of property tax immediately. He has therefore requested that the Government may postpone by one or two half years, the next General revision of tax in respect of the Municipalities mentioned in para 1.

3. The Government after careful consideration accept the recommendation of the Director of Municipal Administration. They accordingly direct that under rule 8(1-A) (a) of Schedule IV to Tamil Nadu District Municipalities Act 1920 the general revision of assessment books in the Municipalities mentioned in para 1, be postponed for a period of two half years with effect from 1-4-1974. This postponement will not affect the subsequent general revision of assessment books.

4. The appended notification will be published in the Tamil Nadu Government Gazette.


