ORDER:

According to the orders in G.O.Ms. No. 1762, Finance dt/27.11.69, According to the orders in G.O.Ms. No. 1762, Finance dt/27.11.6 the family of a Government servant, who dies while in service shall be eligible for the leave salary and allowances left over at the credit of the Government servant on the date of his death subject to a maximum of 30 days. Subsequently in G.O. Ms. No. 1072, Finance ft/18.8.1972, the maximum limit of 30 days has been increased to 120 days, but the leave salary shall be subject to the deductions of family pension and family pension enquivalent to gratuity for this period. This order was given effect to from 18.8.1972. 18.8.1972.

- 2. The Government have examined the question of extending the concessions granted to the Government servants to the employees of Municipal Councils and Township Committees and Madurai Comporation and consider that the concession granted in G.O. Ms. No. 1072, Finance d/18.8.72 may be extended to the employees of Municipal Councils and Township Committees, Madurai Corporation and pass the following orders:
- i) The family of an employee of municipal councils and Town-ship Committees and Madurai Comporation who dies while in service (whether on duty or on leave including leave preparatory to retirement) shall be eligible for the leave salary and allowances for the sarned leave or leave on average pay left over, at the crodit of the local body employee on the date of death, subject to a maximum of 120 days.
- ii) In the case of an employee who dies while on surrender leave but has not drawn the leave salary for the surrendered leave, his family shall be eligible to craw the leave salary for the surrendered portion. In such cases, the period for which leave salary is so allowed will also be taken into account for arriving at the total period of 120 days for leave salary can be allowed under this order.
- iii) The authorities who are empowered to sanction earned leave or leave on average pay to the employee will be competent to sanction the earned leave or leave on average pay and the leave salary and allowances referred to in para 2(i) above to the family of the deceased servant.
- iv) The leave selary and allowances referred to in para 2(1) above, payable to the family of a municipal or corporation employed who dies while service shall be less family pension and family pension equivalent to gratuity for this period.
- v) The concession shall apply to municipal sevent who age on foreign service or on deputation to the Government of India or State Governments.

- vi) The leave salary referred to in para 2(i)above shall be paid to the family of the deceased municipal servant as prescribed in Article 80 of the Madras Financial Code Volume I for the payment of the arrears due to the deceased municipal servants.
- vii) In the case of Municipal servants, a certificate so the effect that the leave salary referred to in para 2(1) above has been drawn and paid to the family of the deceased municipal servant shall be recorded in the Service Register by the drawing officer.
 - viii) The above orders shall take effect from 18.9.72.
