

EDUCATION - Educational concessions to repatriates from Burma and Sri Lanka - Children/grand children born after arrival in India - Not eligible for concessions - Instructions issued.

ORDER:

The Director of Rehabilitation, Tamil Nadu has reported that the Government of India has clarified that the Children grand children of repatriates from Burma and Sri Lanka, born after arrival in India, are not eligible for educational assistance, since by the time such children require education, the repatriates would have rehabilitated themselves.

2) In the circumstances, the Government direct that no educational concession, be sanctioned to the Children/grand children of repatriates from Burma and Sri Lanka, born after the arrival of repatriates in India.

3) The Revenue and Rehabilitation officers who issue the certificates to the effect that the Children of repatriates are their sons and daughters or their grand-children for the purpose of getting educational concessions,

shall verify whether the children/grand children were born before or after the arrival of the repatriates in India and record the same in the certificate, as indicated below:

"Thiru/Tmt./Selvi/Selvan
to whom the educational concession has been applied for was not born after the arrival of his/her parents in India".
