Establishment - Municipal Councils and Township Committees and Madurai Corporation - Reservation of vacancies for Ex-Servicemen in Last Grade Service - orders issued. 

RURAL DEVELOPMENT AND LOCAL ADMINISTRATION DEPARTMENT. Dated: 18th April 1973. G.O.Ms.No.815. Read:

From the Director of Employment and Training, letter No.10555/70/B3 dated 15.10.70 and 30.10.71. From the Director of Municipal Administration, L.Dis.No.72726/70 dated 21.1.71.

ORDER.

The Government of India had reserved 10% of the permanent vacancies in Class III posts and 20% of the permanent vacancies in Class IV posts under the Central Government for Ex-Servicemen. The Director of Employment and Training had suggested that to paye way to improve the employability of Ex-servicement under the local bodies necessary instructions might be issued for considering the possibility of absorbing of Ex-servicement at 10% of vacancies in Class III(Ministerials and allied posts) and 20% in Class IV (Last Grade Service) and to notify such vacancies to the nearest Employment Exchange forsponsoring suitable Ex-service ment against such notified vacancies. The matter was examined and it was considered that orders to be issued in a similar question of making reservation under the State Government service might be followed in respect of reservation under Municipal Councils. respect of reservation under Municipal Councils.

- 2. In respect of Government service it has been decised that 10% of the vacancies in the Tamilnadu Last Grade service along be reserved for the ex-servicement Orders have accordingly been issued in G. O.Ms.No.36, Public (Services) dated 4.1.73. It has been decided that similar orders may be issued reserving 10% of vacancies in the last Grade service under the Municipal Councils and Township Committees and Madural Corporation of Ex-servicemen.
- 3. The Government accordingly direct that 10% of the vacancies in the Last Grade Service under the Municipal Councils and Township Committees and Madurai Corporation be reserved for 3 years from the date of this order for Ex-Servicement, i.e. persons who have been demobilised from the Army, Navy or Air Force.
