

GOVERNMENT OF TAMIL NADU PERSONNEL AND ADMINISTRATIVE REFORMS (A) DEPARTMENT STANDING ORDER NO. 23 OF THE HON'BLE CHIEF MINISTER OF TAMIL NADU, DATED. 23.07.2009

Under sub-rule (4) of rule 35 of Tamil Nadu Government Business Rules, 1978 the Hon'ble Chief Minister of Tamil Nadu hereby makes the following amendments to the Chief Minister's Standing Order No.2, Personnel and Administrative Reforms (A) Department, dated.16.06.2006 and Chief Minister's Standing Order No.4, Personnel and Administrative Reforms (A) Department, dated. 26.07.2006 respectively.

AMENDMENTS

1. In the Chief Minister's Standing Order No.2, Parsonnel and Administrative Reforms (A) Department dated.16.06.2006, for paragraph 3, the following paragraph shall be substituted, namely:-

"3. Official / Private visits abroad:-

The Official / private visits abroad by the officers of All India Service, without any financial commitment on behalf of the State Government shall be disposed of by the Chief Secretary to Government. In other cases orders shall be obtained from the Hon'ble Chief Minister".

2. In the Chief Minister's Standing Order No.4, Personnel and Administrative Reforms (A) Department, dated.26.07.2006, in paragraph one, for the entries starting with the expression 'while taking final decision' and ending with 'District Collectors', the following entries shall be substituted, namely:-

"while taking final decision after examination of the enquiry reports under Police Standing Order 150(3) and Police Standing Order 151 and where it is proposed to disagree with the recommendation of District Collectors, orders shall be obtained from the Chief Minister".

In cases where detailed probe by CB CID is recommended, it is sufficient that orders upto Chief Secretary to Government is obtained.
