## APPENDEX NOTIFICATION.

In exercise of the powers conferred by Section 143A of the Tamil Nadu Public Health Act, 1939 (Tamil Nadu Act III of 1939), and in supersessing of the late Public Health department notification No.993, dated the 8th November 1941, published at page 849 of the Fort St. George Gazette, dated the 18th November, 1941, as subsequently amended, the Governor of Tamil Nadu hereby authorises the Additional Director of Health services and family planning to exercise the powers vested with the Government under sub-section(1) of section 8 of the said Act, subject to the following restrictions, limitations and conditions, namely:-

- (1) The powers shall be exercised only in respect of that part of the public Health establishment of a municipality or a Township committee constituted under the Tamil Nadu District Municipalities Act, 1940, the maximum salary of the members of which does not exceed Rs. 350/- per mensem.
- (2) The additioned Director of Health services and Family Planning shall consult the Director of Municipal Adminstration on each occasion before the powers are exercised.
- (3) If there is a difference of opinion on any question between the Additional Director of Health services and family Planning and the Director of Municipal Administration, the Additional Director of Health services and Family Planning shall refer the question for the decision of the Government.
- 2. The amendment shall be deemed to have come into force from the second October, 1970.
