



NOTIFICATION

In exercise of the powers conferred by Sub-section (1) and clause (1) of Sub-section (2) of Section 303 of the Tamil Nadu District municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamilnadu hereby makes the following amendments to the rules relating to the receipts and expenditure of the Municipal councils published in the Local self Government notification No. 618 dt. the 1st May 1933 at pages 215 to 218 of part IA of the Fort St. George Gazette, dated the 13th June 1933 as subsequently amended.

AMENDMENTS

IN The said rules, in sub-rule(2) of rule 7, the words and counterfoil' shall be deleted.

2. The sub-rule (4) under the said rules shall be deleted.

3. The sub-rule (8) under the said rules shall be renumbered as sub-rule(4).
