ORDER.

In the G.O. read above orders were issued sanctioning an ex-gratic gratia (non-recurring) lump sum bonus of one month's pension subject to a maximum of & 100/- to all the existing Government pensioners and that the above bonus will not be applicable to those who retired on or after 2.10.70 and to those drawing family pension. Therefore the question of granting similar bonus to the municipal employees who retired between 14.1.70 and KYKXX 1.10.70 was considered by the Government in consultation with the Director of Municipal Administration and the Examiner of Local Fund Accounts and they have decided to grant the same to the municipal pensioners. municipal pensioners.

2. Sanction is accorded to the payment of an ex-gratia (non-recurring) lump sum bonus of one month's pension subject to a maximum of &s.100/- (Rupees one hundred only) to all the municipal pensioners of superior service who retired between 14-1-70 and 1-10-70. The bonus shall be based on the pension actually drawn for the month of September 1970 and it will not be admissible to those who retired on an after 2-10-70 and to be admissible to those who retired on or after 2-10-70 and to

those drawing family pension. The bonus shall be paid from out of Municipal Employees' Pension Fund. The Commissioners and Special Officers of Municipalities and the Executive Officers of Township Committees are requested to take action accordingly.

3. The expenditure shall be debited to a new minor head "Municipal Employeest Pension Fund" to be opened under "T Deposits and advances - Deposits bearing interest - Other Deposit Accounts".
