



### **ABSTRACT**

### **ORDER:-**

As per the Government Order first read above, 315 posts in Accounts Wing had been created in the Municipalities. The Commissioner of Municipal Administration in his letter second read above, had sent a proposal for creation of separate new service for the accounts personnel working in the Municipalities.

2) In the meanwhile, the Hon'ble Chief Minister had made, interalia, the following announcement, on the floor of Assembly on 10.04.2013.

“நகராட்சிகளின் கணக்குகளை இன்றைய தேவைக்கேற்ப பராமரிக்கவும் நிதி மேலாண்மையை திறம்படுத்தவும், “தமிழ்நாடு நகராட்சி கணக்கு பணி” என்ற பணியமைப்பு ஒன்று உருவாக்கப்படும் என்பதை தெரிவித்துக் கொள்கிறேன்”

3) Accordingly, the Commissioner of Municipal Administration after consulting with all the Municipal Councils in the State as per sub-section (1) of section 77-A of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), forwarded resolutions obtained from majority of the Municipal Councils supporting the constitution of a new service for the personnel working in the accounts wing of the Municipalities.

4) The Government carefully examined the above proposal of the Commissioner of Municipal Administration and have decided to issue a Notification under sub-section (1) of section 77-A of the said Act.

5) Accordingly, the Notification appended to this order will be published in the **Tamil Nadu Government Gazette**.
