Consequent on the completion (ABSTRACT) the Regional Planning Field Unit at Salem, the Director of Town Planning, ESTABLISHMENT - Office of the Director of Town Planning Madras - powers to dispose of appeals from Municipal Town Planning staff - Now exercised by the Joint Director of Town Planning - Cancelled.

ORDER: In S.O. Ms. No. 1501; dated. 10.11.1960 among other items, the powers vested with the Director of Town Planning to dispose of appeals from the Municipal Town Planning Establishment were delegated to the Joint Director of Town Planning. The Director of Town Planning has now reported that these powers were delegated to the Joint Director of Town Planning at the time when the secretary to the Development Commissioner was appointed to function as ex-office Director of Town Planning who was also functioning as Deputy Secretary to Government besides exercising the powers to the Inspector of Municipalities and that such delegation of powers was considered necessary to relieve him of the work attached to the Department. Now, as a separate officer to function as Director of Town Planning has been appointed, the Director of Town Planning considers that the powers delegated to the Joint Director of Town Planning may be reverted in him.

2. The Government agrees with the suggestion of the Director of Town Planning and the following orders are accordingly issued in the matter.
