ORDER:

In G.O.Ms.No.1596, R.D. & L.A., dated 27.6.1966 the Government ordered the publication of a draft amendment to rule 50A of the Madras Town Planning Rules, 1933. No objection or suggestion to the draft amendment has been received. The Government consider it desirable that the expression "in the manner prescribed in sub-rule (1) above" may be inserted after the expression "under the said part V" in sub-rule (2) of the said rule. The draft amendment as modified is confirmed.

APPENDIX  
Notification.

In exercise of the powers conferred by sub-sections (1) and (2) of Section 44 of the Madras Town Planning Act, 1920 (Madras Act VII of 1920), the Governor of Madras hereby makes the following amendment to the Madras Town Planning Rules, 1933 published with the late Local Self Government Notification No.345, dated the 28th March, 1933, at pages 111 to 122 of part I of the Fort St. George Gazette, dated the 28th March 1933, as subsequently amended:

AMENDMENT.

For rule 50-A of the said Rules, the following rule shall be substituted, namely:-

"50-A(1). Before the expiry of the period prescribed for publication of the draft schemes under section 11 in case of the scheme is taken up under section 9, and before the expiry of the date fixed for preparation, publication and submission of the draft scheme to Government for sanction in case the scheme is taken up under section 12, the Commissioner of the Corporation of Madras or the executive authority of the Municipality as the case may be, shall.

(1) sign a copy of the notification made under Section 10, or the notification made under section 12 and notification or notifications refixing the date for preparation, publication and submission of the draft scheme, as the case may be specifying the date of his signature, the land or lands to which it relates, and the survey number or numbers comprised therein; and

(ii) present the copy so signed or cause it to be presented for registration as soon as possible after such signature, but in any case within the time limit specified in Part IV of Indian Registration Act. 1908.

(2) In the case of any such notification or notifications published before the 16th September, 1966 which has or have not been registered under the said Part IV in the manner prescribed in sub-rule (i) above, the Commissioner or the Executive Authority, shall if necessary sign a fresh copy of the notification within six months from the date aforesaid, and present the same or cause the same to be presented for registration within the time limit specified in Part IV aforesaid for the registration of such copy."
