<u>ORDER</u>

The following amendments are issued to the Government Order 6th read above.

Amendment

The following shall be added as paragraphs 11 and 12 after paragraph 10 therein:-

- "11. Persons who have been appointed temporarily through Employment Exchange as Typist / Steno-typist Grade-III in the Tamil Nadu Judicial Ministerial Service up to 31.03.2008 and continuing in service are eligible to appear for the Special Competitive Examination as ordered in the Government Order 6th read above.
- 12. The temporary Typists and Steno-typists Grade-III who were appointed as per the Government Orders 2nd, 3rd and 5th read above and in Judicial Ministerial

Service as indicated above, and ousted from service for want of vacancy on or after 18.06.2009 (i.e) the date of notification of the Tamil Nadu Public Service Commission, consequent on the appointment of candidates selected by the Commission through direct recruitment for the post of Typist and Steno-Typist Grade-III are also eligible to appear for the above mentioned Special Competitive Examination. Their applications for the above Special Competitive Examination should be forwarded to the Tamil Nadu Public Service Commission by the Heads of Department concerned and in respect of persons who have been appointed in the Departments of Secretariat, their applications should be forwarded by the appointing authorities concerned".
