ABSTRACT

MUNICIPAL ADMINISTRATION - Inclusion of certain areas within Municipal limits of Tiruchirapalli, Tirunelveli and Salem - Retention of Municipal Commissioners and Executive Officers of erstwhile Municipalities and Town Panchayats whose areas have been included, as Zonal Officers - Orders - Issued.

ORDER:

In the G.Os read above the Government have issued orders, including certain adjoining areas comprising Municipalities, Town Panchayats and Village Panchayats, within the limits of Salem, Tiruchirapalli and Tirunelveli Municipalities with effect from 1.4.94 with a view to form Municipal Corporations for these Municipalities.

2. Consequent on the inclusion of these areas within the limits of Tiruchirapalli, Tirunelveli and Salem Municipalities, the Special Officers cum Municipal Commissioners of the original Tiruchirapalli, Salem and Tirunelveli Municipalities have now become the Special Officers cum Municipal Commissioners of the new respective extended Municipalities. The Special Officers cum Executive authorities of the erstwhile local bodies, whose areas have been added to Tiruchirapalli, Tirunelveli and Salem Municipalities, cease to exercise the powers of the Special Officers cum Executive authorities with effect from 1.4.1994.

3. The Director of Municipal Administration has stated that the Executive authorities of these defunct local bodies viz. Municipal Commissioners and Executive Officers of Town Panchayats cannot be withdrawn immediately as they have to settle the accounts and arrange for transferring of assets and liabilities and that till the regular Corporations are constituted for these 3 Municipalities it may be necessary to continue them in the added Municipalities. He has, therefore, suggested that these officers may be

redesignated as Zonal Officers of the respective areas and they may report to the Commissioner of Salem, Tiruchirapalli and Tirunelveli as the case may be. In the case of Village Panchayats which have been included, he has suggested that the Municipal Commissioners of Tiruchirapalli, Tirunelveli and Salem can assume control from the Panchayat Union Commissioners concerned.

4. The Government, after examination, issue the following orders in the matter:-

- (i) The Special Officer cum Commissioner of the original Tiruchirapalli / Salem / Tirunelveli Municipality will become the Special Officer cum Commissioner of the new respective extended Municipality with effect from 1.4.1994.
- (ii) The erstwhile Municipal Commissioners of Srirangam, Golden Rock, Melapalayam, Palayamkottai and Suramangalam and the Executive Officers of the erstwhile Town Panchayats concerned will become the Zonal Officers incharge of the administration for portion of the new Municipality and will report to the Special Officer cum Commissioner of the new extended Municipality.
- (iii) Regarding the erstwhile Village Panchayats, which have now become part of the new extended Municipality, the Panchayat Union Commissioners concerned who used to be the Executive Authorities, will hand over charge to the Special Officer cum Commissioner of the extended Municipalities.
- (iv) Drawal and disbursement of salaries, wages, maintenance charges, contractor's payment and other such payments will in future be done in the name of the new extended Municipality with effect from 1.4.1994. In practice, the payments will be made by the Zonal Officer designated but in the name of the new extended Municipality.
- (v) Similarly all receipts including assigned revenues will also be remitted in the name of the new extended Municipality only.

5. The above arrangement will be an interim one and will be reviewed by the Director of Municipal Administration at the end of six months. He is requested to send a report to Government.

6. The Collectors of Tiruchirapalli, Tirunelveli Kattabomman and Salem Districts are requested to communicate

these orders to the Panchayat Union Commissioners concerned for necessary action.
