ORDER:

In the Government Order read above orders have been issued redesignating the Special Officers - cum - Municipal Commissioner of the erstwhile Tiruchirappalli, Tirunelveli and Salem Municipalities as Special Officers - cum - Commissioners and erstwhile Municipal Commissioners of Srirangam, Goldenrock, Melapalayam, Palayamkottai and Suramangalam and Town Panchayats concerned as Zonal Officers.

2. In para 5 of the Government Order first cited, it has been ordered that arrangement will be reviewed by the Director of Municipal Administration at the end of six months. The Director of Municipal Administration was also requested to send his report to Government in this regard.

This arrangement will be reviewed again by the Director of Municipal Administration at the end of the extended period. The Director of Municipal Administration is requested to send his report in this regard.
