ORDER:

The State Government are getting 75% of the Net Collections under Small Savings as long term loan from Government of India. The net collections under small Savings in Tamil Nadu are poor compared to the Collections in other states. For the year 1989-90 the net collection target under Small Savings has been fixed at Rs.400 crores Government have proposed to provide certain incentives so that the target is achieved in full.

2. Government after careful consideration order implementation of the following scheme for grant of incentives to the local bodies:-

The best panchayats, Panchayat Unions, and Town Panchayats and Municipalities be given incentives, the performance being judged on the percentage of net collection during the financial year in relation to that target fixed to them for that year. The details of incentive are as below:-

- a) Best 5 Panchayats in each district
(Rupees ten thousand only) each : Rs. 10,000
- b) Best 2 Panchayat Unions in each
district (Rupees fifty thousand
only each) : Rs. 50,000
- c) Best Township/Municipality in
each district (Rupees fifty
thousand only) : Rs. 50,000

Total: Rs. 2,00,000

(Rupees two lakhs only per District.

3. The grant of the above incentive shall be subject to the condition that the Local Bodies achieve not less than 50% of the target of net collection fixed by the District Collector. This incentive is in addition to whatever share the local bodies may get from the District incentives at the discretion of the District Collector.

4. The above scheme shall be operative from 1989-90

5. The expenditure on incentives to the local bodies shall be debited to "2047 00. Other Fiscal Services 103 promotion on Small Savings - AF. Schemes implemented by Small Savings - Incentives". (D.P.Code 2047 00 103 AE 0003)

6. The Director of Small Savings is requested to issue necessary instructions to the Collectors for operation of the Scheme including the modalities for disbursement of the incentive amount to the local bodies. He is also requested to give wide publicity to the scheme through newspapers.
