ORDER:-

The Management Committee of the Tamil Nadu Institute of Urban Studies, Coimbatore has, in its Resolution No.23, dated 24.5.1994, Resolution No.17, dated 7.6.1995 and Resolution No.8, dated 20.11.1995 resolved to include (1) the Project Director, Project Management Group (ii) the Director of Town Panchayats and the Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation as members of the Management Committee, as they are also involved in Urban Development activities.

AMENDMENTS
