N O T I F I C A T I O N .

In exercise of the powers conferred by section 25 of
the Madras Public Buildings (Licensing) Act, 1965 (Madras Act
13 of 1965), the Governor of Madras hereby makes the following
amendments to the Madras Public Buildings (Licensing) Rules,
1966.

AMENDMENTS.

In the said rules, in the Table under rule 11---

(1) for the entry in column (2) against item (1) in
column (1), the following entry shall be substituted, namely:--

"An Engineer with a Degree in Civil Engineering of
Indian or Foreign university or a Corporate Member of the

Institution of Engineers (India) or recognised professional Association abroad, such as Institute of Structural Engineers (London), Institute of Civil Engineers (London), American Society of Civil Engineers, etc. and others as may be recognised by the Government of Madras from time to time with not less than five years experience in Building construction or a person possessing a Diploma in Civil Engineering awarded by the State Board of Technical Education and training or with equivalent qualification thereof with not less than five years experience in building construction".

(ii) in the entry in column (2) against item (2) in column (1) after the words "not less than five years experience", the word "in building construction" shall be added.

(iii) in the entry in column (2) against item (3) in column (1) after the words "not less than ten years experience" the words "in building construction" shall be inserted and after the words "with five years experience" the words "in building construction" shall be added.
