ORDER:- No.1880, RURAL DEVELOPMENT AND LOCAL ADMINISTRATION,
DATED 13TH OCTOBER 1967.

In the G.Os. read above, orders were issued authorising the
Tahsildars of the Revenue Department to perform the func-
tions of the Competent Authorities under the Madras Public
Buildings (Licensing) Act, 1965 in respect of the areas speci-
fied therein, under their respective jurisdictions. The
Collector of North Arcot in his reference quoted above, has
raised a point for clarification as to whether the term
" Tahsildars specified in the G.Os. cited will include the
Independent Deputy Tahsildars also. The Government have
examine the point raised by the Collector in consultation
with the Board of Revenue. They have decided to include the
Independent Deputy Tahsildars also for performing the functions
of the competent Authorities under the Act.

" 4. Tahsildar or Independent Deputy Tahsildar in the Nilgiris District.	All buildings in his taluk or sub-taluk, as the case may be, other than those for which the personal Assistant to Collector (General) is the competent authority."
