ACT - Madras Public Buildings (Licensing) Act, 1965 - exemption of certain other categories of buildings from the provisions of the Act for a period of three years - inclusion in notification issued with G.O.Ms.No.2083 R.D. & L.A., dated 30.8.66 amendment - issued.

Read the following:-

G.O.Ms.No.2083 R.D. & L.A., dated 30th August, 1966.

ORDER:

In the G.O. read above orders were issued exempting certain categories of buildings from the provisions of the Madras Public Buildings (Licensing) Act, 1965. The general Manager, Heavy Vehicles Factory, Avadi has requested clarification as to whether the buildings of the factory should be registered under the said Act in spite of the fact that the buildings belong to the Defence Department and the factory premises and the estate are protected areas. The Government after careful consideration of the question have decided to exempt all the buildings owned by the Army, Navy Air Force Defence Science Organisation and the Ordnance Factories from all the provisions of the Act for a period of three years from 1.4.1966.

2. The appended notification will accordingly be published in the Fort St. George Gazette.

Notification.

In exercise of the powers conferred by Section 20 of the Madras Public Buildings (Licensing) Act, 1965 (Madras Act 13 of 1965), the Governor of Madras, hereby makes the following amendment to the Rural Development and Local Administration Department Notification III No.1241 of 1966, dated the 30th August, 1966, published at page 1762 of

of part III of the Fort St. George Gazette dated the 28th September, 1966.

AMENDMENT.

In the said notification--

(1) in the preamble, the following paragraph shall be added at the end, namely:

"The notification hereby issued shall be deemed to have come into force on the 1st April, 1966" and

(2) after item 3 and the entries relating thereto, the following item and entries shall be added namely:--

4. All buildings owned by Army, Navy, Air Force, Defence Science Organisation and the Ordnance Factories under the Ministry of Defence. Three years
