- 2. In the Government Order second read above, the Government has sanctioned and released an amount of Rs.165.09 lakh as 2nd installment of State share for the above Urban Local Body under Integrated Housing and Slum Development Programme scheme.
- 3. In the Government Order 3rd read above, the Government has sanctioned and released an amount of Rs.231.56 lakh as 2nd installment of 50% Central share for the above Urban Local Body under Jawaharlal Nehru National Urban Renewal Mission Integrated Housing and Slum Development Programme scheme.
- 4. The Ministry of Housing and Urban Poverty Alleviation, Government of India in its minutes of the 136th Central Sanctioning Committee (CSC) has approved the proposal of Salem Corporation under IHSDP for release of balance 50% of the 2nd installment.
- 5. In the letter 4th read above, the Government of India have sanctioned and released a sum of Rs.312.05 lakh as balance 50% of the 2nd installment of Government of India share to the Salem Corporation. The details are as follows:-
