ORDER 1-

In continuation of the orders issued in G.O. Ms.No.865, Local administration, dated 30th May 1937, the Government hereby direct that the qualifications and the method of recruitment specified in columns (2) and (3) respectively of the schedule below shall apply to the posts mentioned in column (1) thereof:-

By selection from upper Dn. clerks and Licence inspectors possessing the qualifications prescribed in column (2) <u>Note:</u> The number of Assessors to be recruited from Upper dn. clerks & Licence Inspectors of Revenue Inspras will be in the ratio of 2:1.
