Rules--Madras District Municipalities Act, 1920 --Engineering establishment - Qualification--Draft Amendments--Confirmed.

In the Rules Supplement to Part I-A of the Fort St., George Gazette, dated 19th December 1956, the draft of certain amendments to the rules relating to Engineering establishment under municipal councils was published for general information. No objection or suggestion in respect of the draft amendments has been received. The draft amendments are hereby confirmed. The appended notification will be published in the Fort St., George Gazette.

APPENDIX.

In exercise of the powers conferred by sections 74(b) and 303(2) of the Madras District Municipalities Act, 1920 (Madras Act V of 1920), the Governor of Madras hereby makes the following amendments to the rule prescribing the qualifications of officers and servants of the Engineering establishment under municipal councils, published with the late Local Self-Government Department Notification No.1579, dated the 21st September 1932, at pages 1006-1007 of Part I-A of the Fort St. George Gazette, dated the 1st November 1932, as subsequently amended, a draft of the same having been previously published as required by section 304(a) of the said Act:-

Amendments.

In the said rule:

(1) for the opening paragraph beginning with the words "No person" and ending with the words "thereof" the following paragraph shall be substituted, namely:-

"No person shall be appointed to any of the posts under a municipal council specified in column (1) of the annexed table unless he possesses the qualifications laid down in the corresponding entry in column (2) thereof or such other qualifications as may be considered by the Government to be equivalent to the said qualifications" and

(2) in the table:

(a) for the entries in column (2) against item (1) "Supervisors", the following entries shall be substituted, namely:-

- (i) the degree in Engineering of a University in the State
- or (ii) the diploma in Engineering of the College of Engineering, Guindy or (iii) the Upper Subordinate Diploma or the Licenciate in Civil Engineering Diploma of the College of Engineering, Guindy
- or (iv) the Lower Subordinate Diploma of the College of

(iv) the Lower Subordinate Diploma of the College of Engineering, Guindy with practical experience for not less than years; or (v) Licenciate in Civil Engineering Diploma or Licenciate in Sanitary Engineering Diploma awarded by the Technological Diploma Examination Board, Madras;

Provided that:

-- (i) No candidate possessing the Upper Subordinate Diploma or the Licenciate in Civil Engineering Diploma of the College of Engineering, Guindy, or the Licenciate in Civil Engineering Diploma or the Licenciate in Sanitary Engineering Diploma awarded by the Technological Diploma Examination Board, Madras, shall be eligible for appointment, if a suitable candidate possessing the degree in Engineering of a University in the State of the Diploma in Engineering of the College of Engineering Guindy, is available for such appointment; and

(ii) no candidate possessing the diploma in Engineering Guindy, shall be eligible for appointment, if a suitable candidate possessing the degree in Engineering of a University in the State is available for such appointment";

(b) for the entries in column (2) against item (2) "Overseer the following entries shall be substituted, namely:-

"(i) The Upper Subordinate Diploma or the Licenciate in Engineering Diploma of the College of Engineering, Guindy; or

(ii) The Lower Subordinate Diploma or the Overseer Diploma of the College of Engineering, Guindy, or of the Technological Diploma Examination Board, Madras; or

(iii) Licenciate in Civil Engineering Diploma or Licenciate in Sanitary Engineering Diploma awarded by the Technological Diploma Examination Board, Madras; or

(iv) the group certificate in Sanitary Engineering in the Government Technical Examinations with five years' experience as draughtsman under a municipal Council; or

(v) the New Overseer Diploma of the College of Engineering Guindy"; (c), for the entries in column (2) against item (3) "Draughtsman", the following entries shall be substituted, namely

"(i) A Lower Subordinate Diploma of the College of Engineering, Guindy; or (ii) a Diploma of Draughtsman recognized the Government of Madras; or (ii) a pass by the lower grade in Government Technical Examination in:

- i. Building, Drawing and Estimating;
- ii. Building Construction and Materials;
- iii. Surveying and Levelling;
- iv. Applied Mechanics;
- v. Geometrical Drawing; or

(iv) five years' service as a fully qualified tracer and a pass by the lower grade in the Government Technical Examination in Building Construction and Materials; or

(v) The Overseer Diploma of the College of Engineering Guindy, or of the Technological Diploma Examination Board, Madras

(vi) Licenciate in Civil Engineering Diploma or Licenciate in Sanitary Engineering Diploma awarded by the Technological Diploma Examination Board, Madras; or

(vii) The ~~new~~ group certificate in Sanitary Engineering in Government Technical Examinations; or

(viii) The New Overseer Diploma of the College of Engineering Guindy,

Provided that preference shall be given to candidates with higher qualifications, if available";

(d) in column (2) against item (5) "Drivers (Mechanical)" the words "or the All-India Certificate in Mechanical Engineering of the All-India Council for Technical Education, or the L.M.E.E. Dip., of the Osmania Technical College, Hyderabad, occurring in clause (c) (i) , shall be omitted;

(e) in column (2) against item (6) "Drivers (Mechanical)" the words "or the All-India Certificate in Mechanical Engineering of the All-India Council for Technical Education, or the L.M.E.E., Dip. of the Osmania Technical College, Hyderabad," occurring in clause (c) (i) shall be omitted;

(f) in column (2) against item (7) "Head Works Fitters, (Mechanical) mechanics and turners", the words "or the All India-Certificate in Mechanical Engineering of the All-India Council for Technical Education" occurring in clause (b) shall be omitted;

(g) in column (2) against item (9) "Superintendents (Electrical)" the words "or the All-India Certificate in Mechanical Engineering of the All-India Council for Technical Education, or the L.M.E.E., Dip., of the Osmania Technical College, Hyderabad", occurring in clause (a) shall be omitted;

(h) in column (2) against item (10) "Superintendents (Mech)" the words "or the All-India Certificate in Mechanical Engineering of the All-India Council for Tech. Education, or the L.M.E.E., Dip., of the Osmania Technical College, Hyderabad, occurring in clause (e) (i) shall be omitted; and

(i) in column (2) against item (11) "Electricians" the words " or who hold the L.M.E.E., Diploma of the Osmania Tech., College, Hyderabad", occurring in the proviso, shall be omitted.
