ORDER :-

At first, there were different scales of pay for the posts in class III and Class IV in Municipalities, as shown below:-

(1) Class III

Assistant Revenue Officer Rs. 300-10-350-15-500
and Assistant Accountant.

(2) Class IV

Managers Grade III and Grade
II, Revenue Officers and Rs. 275-10-375-15-450.
Accountant in first
Grade Municipalities.

Subsequently, the Third Pay Commission fixed a uniform pay scale of Rs. 450-20-590-25-740-30-800 for both class III and IV services. Since the posts in two classes had been placed on the same status, the Director of Municipal Administration has been requested to examine the matter in the light of the above fact and suggest suitable draft amendments. The Director of Municipal Administration has sent necessary draft amendments in this regard. He has also sent draft amendment regarding the post of Revenue Inspector which has been upgraded as Assistant's post in G.O.Ms.No. 1951, R.D.& L.A., dt. 25.11.1981. The Government have decided to accept the amendments proposed by the Director of Municipal Administration.

APPENDIX

NOTIFICATION.

In exercise of the powers conferred by sub-section(2) of Section 77-A of the Tamil Nadu District Municipalities Act, 1920 (Tamil Nadu Act V of 1920), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Municipal General Service Rules, 1970 (in part III- Special Rules - Section 1 of the Tamil Nadu Municipal Service Rules, 1970).

AMENDMENTS.

In the said Rules,--

1. In rule 1, ---

(a) "Class III" and the entries thereunder shall be omitted;

(b) "Class III-A" shall be renumbered as "Class III";

(c) for the entries under class IV, the following entries shall be substituted, namely:-

Category 1 - Assistant Revenue Officers,
Selection Grade Municipalities.

Category 2 - Assistant Accountants, Special and
Selection Grade Municipalities.

Category 3 - Managers, II and III Grade Municipalities.

Category 4 - Revenue Officers, I Grade Municipalities.

Category 5 - Accountants, I Grade Municipalities"

d) under Class V, after category 7, the following category shall be added, namely:-

"Category 8 - Revenue Inspectors";

e) for the entries under Class VII, the following entries shall be substituted, namely:-

"Category 1 - Junior Assistant

Category 2 - Poor House warden

..3..

Category 3 - Shroff

Category 4 - Storekeepers, II Grade";

2. In rule 3, ----

(a) in sub-rule (a), in clause (i) under Class VII, "category 2" shall be omitted; and "Categories 3, 4 and 5" shall be renumbered as "Categories 2, 3 and 4" respectively;

(b) in the Table under sub-rule (b), --

(i) "Class III" and the entries thereunder in column (1) and the corresponding entries in column (2) shall be omitted;

(ii) "Class III-a" in column (1) shall be renumbered as "Class III";

(iii) for the entries under class IV in column (1), the following entries shall be substituted, namely:-

*Category 1 - Assistant Revenue Officers,
Selection Grade Municipalities.

Category 2 - Assistant Accountants, Special and
Selection Grade Municipalities

Category 3 - Managers, II and III Grade Municipalities.

Category 4 - Revenue Officers, I Grade Municipalities.

Category 5 - Accountants, I Grade Municipalities";

(iv) under class V, after category 7 in column (1) the following category shall be added, namely:-

"Category 8 - Revenue Inspectors";

3. in rule 4, --

(a) in sub-rule (a), the expression "~~III-A~~" in column (1) shall be omitted;

(b) in sub-rule (b), the expression "III-A" in column (1) shall be omitted;

4. in rule 7, --

- (a) in the entry in item 1 in column (1), for the expression "Classes I, and I-A, II and III", the expression "Classes I, IA and II" shall be substituted; and
- (b) in the entry in item 2 in column (1) for the expression "Class III-A", the expression "Class III" shall be substituted.
