ORDER :-

In the Government order first read above, the Heads of Departments were authorised to sanction advance of pay to Gazetted Officers who are either on transfer or on initial appointment tonewly created posts.

2. In his letter second read above, the Accountant-General has stated that it was observed that there was not a single case where an officer who was either newly appointed or promoted had to wait for two months for want of pay slip from his office necesitating the invoking of the provisions in the Government order first read above for the drawal of advance. He has further stated that in extreme cases, no problem is anticipated as provisional pay slips can be issued, with the result there may not be any occasion in future also for the invoking of the provision in the Government order first read above by the self drawing officers. He has also stated that the position obtaining in his office was communicated to the Director of Treasuries and Accounts who, in turn, has issued instructions to all the Pay and Accounts Officers in city to follow the same practice in respect of offices in the city. In view of the above, the Accountant-General has requested the Government to consider rescinding the orders issued in the Government order first read above. The Director of Treasuries and Accounts also in his letter third read above, has stated that he has no objection for rescinding the orders already issued in the Government order read above

3. After careful examination, the Government have decided to accept the suggestions of the Accountant-General and the Director of Treasuries and Accounts in paragraph 2 above and they accordingly direct that the orders issued in the Government order first read above be rescinded.
