Commissioners and Secretaria to Government and the Commissioners who are appointed in lieu of Members, Erstwhile Board of Revenue may purchase any seven of the following newspapers:

- 1. The Hindu. 2. The Indian Express.
- 3. The Financial Express.
- 4. The Economic Times
- 5. Dinamani.
- 6. Dailythanthi (Dinathanthi)
- 7. Dinamalar.
- 8. Makkalkural.

The Secretaries to Government may decided to which of the officers in their departments these newspapers should be supplied and whether in their offices or residences for purposes of news scruting and follow up.

The other officers, VIz Heads of Departments Collectors Superintendents of Police and Deputy Inspectors General of Police having independent offices may purchase any four of the above newspapers.

Joint Secretaries to Government and Additional Secretaries to Government may purchase any two of the newspapers mentioned above
