## ABSTRACT

## ORDER:

In G.O.Ms.No.747, Housing and Urban Development, dated 11.5.79, the Government prescribed the revised procedure for the recovery of rent from the officers occupying Middle Incame Group flats under Government quota and sanction of economic rent to the Housing Board.

- 2. The Government have examined the case further in the light of the difficulties encountered in getting recovery details. In partial modification of the orders issued in the G.O. read above, the Government prescribe the following revised procedure in respect of recovery of rent and sanction of economic rent:
  - (i) Allottees of Middle Income Group flats both in the city and in the mofusil should furnish a certificate as in the proforma I annexure! to this order, to the Chairman Tamil Nadu Housing Board on or before 10th of every month.
  - (ii) In respect of non-Gazetted Officers
    ceupying Housing Board flats the
    certificate should be ENTINENT ENGRENT
    countersigned by the Pay Disbursing
    Officers and sent to the Tamil Nadu Housing
    Board on or before 10th of every month.
  - (iii) In respect of Officers and staff working in Government Undertakings/Local bodies, a certificate furnishing the particulars as detailed in Proforma II annexed to this order should be furnished by the concerned officials in the Government Undertakings/Local Bodies who are authorised to issue certificate in this regard to the Tamil Nadu Housing Board on or before 10th of every month. The individuals will also be responsible to the

early issue of the above certificates.

- (iv) The Tamil Nadu Housing Board should prefer claims on receipt of the certificates mentioned above, for sanction of the economic rent by the Government in Housing & Urban Development Department.
- (v)The Government will sanction the economic rent to the Housing Bærd with the concurrence of Finance Department subject to the condition that the occupants should forego House Rent Allawance and 10% of pay.
- The above procedure will be adopted from the year 3. The 1982-83.
- Regarding back periods, the Tamil Nadu Housing Board should get their claims based on the existing arrangements.
- 5. This order issues with the concurrence of Fina me Department vide its U.O.No.120806/Raf/82 dated 5.11.1982.
