APPENDIX  
NOTIFICATION

In exercise of the powers conferred by clause (j) of sub-section (2) of Section 122 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972) the Governor of Tamil Nadu hereby makes the following amendment to the "Preparation and sanction of Detailed Development Plan Rules approved in G.O.Ms.No. 652 Rural Development and Local Administration dated 9.4.1975 published in Tamil Nadu Government Gazette dated 7.5.75, Part II, Section 1A, pages 384 to 401.

AMENDMENT

In the said rules

(1) in rule 7, in sub-rule 3(a) for the expression "in clause (b)" the expression "in clause (c) shall be substituted.

2. In rule 14, clause (c) shall be renumbered as clause (d) and before clause (d) so renumbered, the following clause (c) shall be inserted:-

"14(c):- The Collector shall verify the particulars specified in the plan and the maps and schedules sent to him as per rule 13 and offer opinion in respect of Government Lands" within two months.

3. in rule 15, in sub-rule (1) the expression "and the Collector occurring after the expression "through the Regional Deputy Director" shall be omitted.

4. in annexure 1 the following entry shall be added at the end, namely:-

10. District Collector of the concerned District

5. Rule 15(3) shall be deleted.
