Order:--

In the Third Report of Public Undertakings Committee in paragraph 30, the Committee has recommended that reservation of Tamil Nadu Housing Board's plots/ flats/houses should also be made for physically handicapped and political sufferers. The Chairman,

Tamil Nadu Housing Board has requested orders of the Government on the above recommendation. In the U.O. Note 12th read above, Social Welfare Department has requested that in view of the declaration of the year 1981 as 'International year of the Disabled persons' orders may be issued on the recommendations of the Director of Social Welfare that 3% of the Tamil Nadu Housing Board's houses/flats may be allotted to physically handicapped persons. Housing is one of the Sectoral programmes in the Special Component Plan for the development of the Scheduled Castes/1980-85 introduced by the Government of India which emphasises that the task of the development of Scheduled Castes must receive the highest priority.

2. The Government have examined the above proposals and they have decided that the existing reservations for the Scheduled Castes/Scheduled Tribes in the allotment of Tamil Nadu Housing Board's plots/houses/flats on Hire Purchase basis be increased from 10% to 18% and that 1% may be reserved for physically handicapped persons and another 1% may be reserved for political sufferers. The Government have also decided that 5% of the plots/houses/flats constructed by the Tamil Nadu Housing Board be reserved for Artistes i.e. those who are engaged in artistic professions of music, dance, acting and pcem composing. The above reservations should be distributed among the categories of Scheduled Castes and Scheduled Tribes, Dhobies and Barbers and General Public without affecting the quotas prescribed for these categories as Artistes, Political sufferers and physically handicapped persons will also belong to the categories viz. Scheduled Castes/Scheduled Tribes/ Dhobies and Barbers/General Public. The applications received from the Artistes, Political sufferers and Physically handicapped persons should be sorted out separately and from these applications such of those who belong to the Scheduled Castes/Scheduled Tribes, Dhobies and Barbers, General Public should be separately categorised and lots should be drawn first for allotment of plots/houses/flats to these people i.e. Artistes/ Political sufferers/Physically handicapped persons upto a maximum of 5%/1%/1% for Artistes, Political sufferers, and physically handicapped persons respectively and then the .balance after allotment to the above special categories may be made available for allotment to the remaining Scheduled Castes/ Scheduled Tribes, Dhobies and Barbers and General Public.

(Out of this 1% is reserved for allotment to Ex-servicemen belonging to Tamil Nadu who are receipients of the gallantary awards such as Param Vir Chakra, Vir Chakra, and Maha Vir Chakra).

From out of the categories in items (i), (v) and (vii), 5% for Artistes, 1% for political sufferers, and 1% for Physically handicapped will bealfotted on priority basis by following the procedure detailed in paragraph 2 above.

- 4. The Government accept the following recommendations of the Chairman, Tamil Nadu Housing Board made in his letter 13th read above:--
 - (i) Suitable column for physically handicapped persons may be provided in the Application forms to be sold in future by the Tamil Nadu Housing Board;
 - (ii) Crippled persons, if successful in the lots conducted by the Tamil Nadu Housing Board, may be allotted Ground floor flats under Government discretionary quota.

If any ground floor flats are left unallotted for want of applications, such flats may be allotted to the successful crippled persons by the Allotment Committee itself.

- 5. The Chairman, mamil Nadu Housing Board is requested to announce the revised referrations in the Newspapers while inviting applications for allotment of plots/flats/houses on hire purchase basis in the various scheme areas in future.
 - 6. G.O.Ms.No. 631, Housing and Urban Development

dated 29-7-1981 the Government have ordered, inter-alia, that 20% of the plots developed and 20% of the houses constructed by the Madras Metro-politan Development Authority in Maraimalai Nagar, Manali Sites & Services Scheme areas and other areas developed under the World Bank Projects be reserved for allotment to Scheduled Castes/Scheduled Tribes.
