ORDER:

In the Government Order first read above, the Government accorded sanction and released a sum of Rs.95.84 lakh as central share and state share for improvement of Water Supply Scheme to Nerkundram Village Panchayat.

2. In Government Order second and third read above, the Government had released 2nd installment of Government of India and Government of Tamil Nadu share for Improvement of Water Supply Scheme to Nerkundram under UIG scheme of Jawaharlal Nehru National Urban Renewal Mission (JNNURM).

In Government of India letter dated 22.08.2013 the Government of India had released Rs.1,67,74,000/- for Providing Comprehensive Water Supply Scheme to Nerkundram project towards 3rd installment sanctioned under Jawaharlal Nehru National Urban Renewal Mission Urban Infrastructure and Governance Scheme (JNNURM UIG).
- 4. Now, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to release the Government of India's share of Rs.167.74 lakh and Government of Tamil Nadu matching share of Rs.71.89 lakh, totaling to Rs.239.63 lakh towards 3rd installment for providing comprehensive Water Supply Scheme to Nerkundram under Jawaharlal Nehru National Urban Renewal Mission Urban Infrastructure and Governance Scheme (JNNURM UIG) scheme, is as follows:-
