

Establishment - Corporation of Madras - Labour
establishment - Settlement of Terminal benefits
Age of superannuation and counting of service
under fixed wages

The Government direct that the age of retirement on Superannuation for the category of employees such as drivers, Mechanics, Artisans, Brick layers shall be fixed at 53 years and the service rendered by these categories of employees beyond 53 years shall be treated as re-employment.

Advances - Coimbatore Corporation - H.B.A.
benefit extended to the employees of Coimbatore Corporation - Orders issued.

The Government extended the grant of House Building Advance to the employees of Coimbatore Corporation subject to the following conditions:

(i) Rules applicable to the Government employees issued from time to time in respect of House Building Advance should be made applicable to the Corporation of Coimbatore employees

(ii) Interest should be calculated at the rate fixed by Government applicable to Government servants

(iii) The advance should be met from the funds of the Coimbatore Corporation

(iv) A limited provision should be made in the Coimbatore Corporation revenue budget every year for House Building Advance and the grant of advance during the year should not exceed this provision

(v) Effect from the date of order

1. In the case of employees already retired, the Municipal Contribution of Rs. 5000/- may be paid to them from the funds of the respective Municipalities without recovering the arrear subscription.

2. The recovery of subscriptions may be made only to the rate of 1+1 as ordered in G.O.Ms.No.629/MA&WS/dt 28.5.86. The rate of recovery may not be increased in such a way to complete the recovery of entire arrear subscriptions before the date of normal retirement. In such cases when an employee is retired the amount due as per the table with reference to the number of recoveries actually effected may be paid to him with accrued interest.

3. The suggestions of the Examiner of Local Fund Accounts that the Ex-authority of the Municipal Councils and Township Committees may be permitted to refund the subscriptions recovered from the retired employees with interest as per the table along with the Municipal Contribution of Rs.5000/- as suggested in paras 3 & 4 of the letter No. 21971/PV.I/86-1, dated 16.5.86 from the Examiner of Local Fund Accounts is accepted. The interest portion has to be borne by the Municipalities themselves from their general funds.

2 An indemnity bond should be taken from the nominee/dependents of the employees that all payments will be adjusted against the payments due to the employee in case he appears on the scene and makes any claim.
