ORDER:

At the Executive Committee and General Body Meetings of the Municipal Town Planning Officers held on 5.4.75 and 11.5.75 it was resolved in Resolution No.10, to request the Government, among others, to amend the Rules 11(2) and 13(2) of the Tamil Nadu District Municipalities Building Rules, 1972 as shown in the Annexure in order to overcome the difficulties experienced by the public and the Town Planning Officers in implementing the rules. 2. The matter has been examined in km consultation with the Director of Town and Country Planning and the Inspector of Municipalities. Regarding Rule 11(2)(a) the Director of Town and Country Planning, Madras has stated that, from the past experience, it is revealed that avoidance of encroachment by insisting on this rule is considered impracticable due to prevalence of sections 180 x to 183 of Tamil Nadu District Municipalities Act 1920 and unless the rule is made so rigid, encroachments could not be arrested. Hence, it is desirable that rule 9(2)(a) of the old building rule 1942 may be revived with a sub-rule inserted as follows:

"In the case of a public or private street, not being a conservancy lane, no building (except a **x** plinth step and other similar structure net being above the lowest floor lever of the building and any fence not exceeding 8 feet in height) shall be built.

- i. Within four feet of the boundary of the street.
 ii. Within six feet from the centre of the street;
 - iii. in the space between the building line and the street alignment as defined under section 166 of the Act".

The Director has agreed with the suggestion of the Town Planners' Association to amend Rule 13(2) of the said Rules The Inspector of Municipalities has also agreed with the views of the Director of Town and Country Planning, Madras.

- 3. The Government accept the recommendations of the Director of Town and Country Planning, Madras, and the Inspector of Municipalities and direct that Building Rules 11(2)(a) and of the Tamilnadu District Municipalities Building Rules, 1972 be amended as shown in the Appendix.
- 4. The appended notification will be published in the Tamilnadu Government Gazette.
