Licences - Municipalities and Panchayats Machineries - Small scale industries - Alterations and additions in the existing units not exceeding 25 H.P. - permission of Health authorities not necessary - Orders - Issued.

ORDER:

In the Government Order 2nd read above, the Government have is sued orders to the effect that applications for construction of factories with a connected load not exceeding 25 H.P. coming up in the area notified as industrial areas in Panchayat and Municipalities need not be referred to the Directorate of Town and Country Planning.

- 2. In the Government order Ist read above, the Government have issued orders to the effect that whenever units other than 14 lines of production mentioned in the Government Order which are set up in small scale sector in locations declared as industrial areas by the local bodies concerned no prior clearance from the Health Department is required.
- 3. The director of Industries and Commerce has stated that some of the existing small scale industries running units who have already got the approval from District Health Officer, Inspector of Factories and Town and Country Planning Departments intending to shift the machinery within the same building, or adding machineries in the building or construction of additional building for installation of machineries in the same premises or making any alteration of to suit their process requirement, have been asked to obtain clearance again from the District Health Officer. The Director of Industries and Commerce has added that the insistance of the 2nd approval by the District Health Officer in respect of industries, requiring additions and alteration in building, erection of machineries and enhancement of Horse Power etc. will not serve the object of the Government orders to remove the difficulties found of the Government orders to remove the difficulties faced by small scale industries.
- 4. The Director of Industries and Commerce has further stated that once the site has been approved and permission granted for running an industry, the same place may be ordered as industrial area and the licence may be issued forthe industries whose power requirement is below 25 HP without referring to District Health Officer on due recommendation by the District Industries Contract Transfer C by the District Industries Centre.
- 5. The Director of Industries and Commerce has requested the Government that necessary orders may be issued relaxing

of second approval from the District Health Officer in respect of existing small scale industries units.

- 6. The Government accept the recommendation of the Director of Induatries and Commerce and accordingly direct that in the case of small scale industries which are running units with licences, the approval of the District Health Officer should not be insisted for shifting the machinery within the same building, or for the addition of machineries in the same premises or for construction of additional buildings for meeting their process requirement in the total installed capacity does not exceed 25 H-P.
- 7. The executive authorities of the municipalities and panchayats are requested to follow the instructions in paragraph 6 above in the matter is grant of licences.
- 8. The Director of Rural Development and the Director of Town Panchayats are requested to communicate copies of this Government Order to all Panchayat Union Commissioner and Executive Officers of Town Panchayats.
