In the letter second read above, the Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited has requested the Government to issue order to draw the above funds of Rs.15095.82 lakh towards 3rd and 4th installment of Government of India share and Government of Tamil Nadu share for the above projects under Jawaharlal Nehru National Urban Renewal Mission Urban Infrastructure Governance scheme.
- 3. The Government, after careful examination accept the proposal of Chairman and Managing Director, Tamil Nadu Urban Finance and Infrastructure Development Corporation Limited and accord sanction and release an amount of Rs.150,95,82,000/- (Rupees One Fifty crore ninety five lakh eighty two thousand only) towards 3rd and 4th installment of Government of India and Government of Tamil Nadu share (GOI share Rs.10726.41 lakh + GOTN share Rs.4369.41 lakh)for the projects mentioned at para 1 above under Jawaharlal Nehru National Urban Renewal Mission-Urban Infrastructure Governance scheme.
- 4. The amount sanction in para 3 above shall be debited under the following head of account :-

Other Urban Development Schemes 800 Other expenditure - Schemes in Twelfth Five Year Plan - II State Plan - JL Jawaharlal Nehru National Urban Renewal Mission (JNNURM) - Submission for Urban Infrastructure and Governance 09 Grant in Aid 01. Grants for Current Expenditure (DPC 2217 05 800 JL 0914)".

"The amount sanctioned shall not be paid in cash but credited to the following head of account:-

"K Deposits and Advances - (b) Deposits not bearing interest - 8443.00 Civil Deposits - 800 Other Deposits - DA -Deposits of TNUID and RF (DPC 8443 00 DA 000A) (Receipts) DPC 8443 00 800 DA 0000(outgo)".

The Commissioner of Municipal Administration is authorized to draw the amount sanctioned in para 3 above by means of an account payee cheque drawn in favour of "Tamil Nadu Urban Finance and Infrastructure Development Renewal Fund" to the P.D.Account (No.01G 03099750BQ) and disburse the same to "Tamil Nadu Urban Infrastructure Development and Renewal Fund".
