### ORDER:

In the Government Order first and second read above, the Government had accorded sanction and released 2nd installment fund of Government of India and Government of Tamil Nadu share to Kovilpatti under Integrated Housing and Slum Development Programme scheme of Jawaharlal Nehru National Urban Renewal Mission.

- 2. In the Government Order third read above, the Government had accorded sanction and released 50% of 2<sup>nd</sup> installment for an amount of Rs.304.62 lakh of Government of India and Government of Tamil Nadu share to Kumbakkonam Municipality.
- 3. In the letter fourth and fifth read above, the Government of India had released remaining share for an amount of Rs.172.46 lakh as final installment to Kumbakonam and Kovilpatti Municipalities.
- 4. In the letter sixth read above, the Commissioner of Municipal Administration has requested the Government to issue orders for sanction and release an amount of Rs.309.09 lakh of Government of India share and Government of Tamil Nadu share (GOI share Rs.172.46 lakh + GOTN share Rs.136.63 lakh) as final installment to Kumbakonam Municipality and remaining share to Kovilpatti Municipality for the year 2014-15 under Jawaharlal Nehru National Urban Renewal Mission Integrated Housing and Slum Development Programme scheme.
- 5. The Government after careful examination accept the proposal of the Commissioner of Municipal Administration at para 4 above and accord sanction and release an amount of Rs.309.09 lakh of Government of India and Government of Tamil Nadu share (GOI share Rs.172.46 lakh + GOTN share Rs.136.63 lakh) as final installment to Kumbakonam Municipality and remaining share to Kovilpatti Municipality under Integrated Housing and Slum Development Programme scheme for the year 2014-15 as appended in **Annexure** to this order.
