ORDER :-

In the Government Order 24th read above, orders were issued fixing the inter-se-seniority of the Municipal Commissioners recruited through various methods between 1989 to June 1997 as per Rule 35(aa) of the General Rules for the Tamil Nadu State and Subordinate Service.

2. The Commissioner of Municipal Administration, now, in the letters 33rd read above has sent proposals for fixation of inter-se seniority of the Grade-II Municipal Commissioners who were appointed / brought into the cadre of Municipal Commissioner Grade-II, between June 1997 and August 2012 vide Government Orders 2nd to 23rd and 25th to 28th read above, as per the proviso in 2 (c) of Special rule for Tamil Nadu Municipal Commissioners' Subordinate Service and also as per Rule 35(aa) of General Rules for the Tamil Nadu State and Subordinate Service. The services of the individuals referred to therein, were regularized in the post of Municipal Commissioner, Grade-II, in the Government Orders 29th to 32nd read above.
