ORDER:-

In the letter read above, the Commissioner of Municipal Administration has stated that the Virudhunagar Municipality was constituted as Third Grade Municipality on 12.03.1915 and upgraded as First Grade Municipality on 18.10.1956. This is a district head quarter town, connected by both road and rail. The extent of the town is 6.64 sq.km and the population is 72,144 as per 2011 census. The Municipality is maintaining road length of 105.720 kms, 3,215 No. of street lights, only one park, 1 bus stand, 1 Truck terminal. A total quantity of 7.87 Million Litre per Day of water is supplied by the Urban Local Body through its 76 km of water pipeline.

2. The Commissioner of Municipal Administration has further stated that the Virudhunagar Municipality is due to celebrate its Centenary Celebration during the year 2015 (13.03.2015). To celebrate the occasion, the Municipal Commissioner, Virudhunagar, has sent a proposal requesting for sanction of Rs.25.00 crore as a special grant to undertake certain basic infrastructure works, as detailed below:-
