WATER SUPPLY - Salem District - Combined Water Supply Scheme to 698 Rural habitations in Nangavalli and Mecheri Unions, with bulk provision for 6 Town Panchayats, in Salem District with River Cauvery as source at a cost of Rs.158.64 crore to install and Rs.6.90 crore to maintain annually - Approved by the Empowered Committee - Administrative Sanction - Orders issued.

#### **ORDER:**

The Honorable Chief Minister of Tamil Nadu during the Collectors' conference held on 19.12.2012, among others made an announcement that "Drinking water facilities will be provided for Mecheri and Nangavalli Blocks in Salem District" [Announcement No:168]

2. The Managing Director, Tamil Nadu Water Supply and Drainage Board in his letter read above, has stated that Detailed Project Report has been prepared for providing Combined Water Supply Scheme to 698 Rural habitations in Nangavalli and Mecheri Unions with bulk provision for 6 Town Panchayats in Salem District with River Cauvery as source at a cost of Rs.158.64 crore to install and Rs.6.90 crore to maintain annually. The Per capita cost is Rs.5309/-.The cost per 1000 litres is Rs.21.66.

The Managing Director, Tamil Nadu Water Supply and Drainage Board has further informed that it is proposed to tap surface water through intake well to be located in the eastern bank of River Cauvery near Reddivur in the downstream of Mettur dam south of Thottilpatti. This site is located about 4 Km upstream of Chekkanur barrage and about 2 km south of the bridge crossing (near Thermal Plant) the River Cauvery. It is proposed to construct a Treatment Plant of 23.45 MLD capacity (Ultimate Stage) at Veerakkal where adequate land is available. The Treatment Plant Comprises of Aerator, Stilling Chamber, Measuring Channel, Flash Mixer, Clariflocculator and Filter cum Chemical House with 8 Nos. of Filter Beds (one No. as stand by), clear water Reservoir and Pump House. The Clearwater Reservoir of 13.10 LL capacity is proposed to be constructed with a detention time of 1 hour. From the treatment plant, water will be pumped to 6 panchayats in Nangavalli union by means of Centrifugal pumpsets of duty 6641 lpm x 61m head upto Break Pressure Tank of 12.30 LL capacity at Vanavasi School in Nangavalli union (including bulk provision for Nangavalli, Vanavasi and Jalakandapuram town panchayat). Water will be pumped from clear water reservoir to Amman Koilur sump with open well submersible pumpset of duty 683 lpm x 46 m through separate pumping main for the requirement of Veerakkal and Sanarapatty Panchayats. Bulk quantity provision for Veerakkal Pudur and P.N. Patty Town Panchayat is made in the clear water sump which will be tapped when requirement arises.

From the clear water reservoir, the requirement of 4 Panchayats of Mecheri Union and Konur Panchayat of Nangavalli union will be pumped by means of HSC pump set of duty 3057 lpm x 64m.

From the clear water reservoir, the requirement of 13 Panchayats will be pumped to 12.30 LL capacity MSR at Mecheri by means of HSC pumpset of duty of 6242 lpmx 57m head (including bulk provision for Mecheri town panchayats) From the Mecheri MSR, the requirement of 6 Panchayats will be gravitated to the respective sumps. From the MecheriMSR water will be pumped to Amaram Thittu sump and from there the requirement of 4 Panchayats will be pumped. Another gravity main is laid from Mecheri MSR upto ridge point sump at Koonandiyur to tap the requirement of 3 Panchayats.

The Government after careful consideration, accord Administrative Sanction for the implementation of Combined Water Supply Scheme to 698 Rural habitations in Nangavalli and Mecheri Unions with bulk provision for 6 Town Panchayats in Salem District at a cost of Rs. 158.64 Crore to install (Rupees One hundred fifty eight crore and sixty four lakh only) and Rs.690.00 lakh (Rupees six hundred and ninety lakh only) to maintain annually and to implement with following funding pattern, through Tamil Nadu Water Supply and Drainage Board.
