ORDER:

In the letter first read above, the District Collector, Madurai has stated that the Commissioner, Madurai Corporation has requested him, to recommend and forward the following project of Madurai Corporation to the Commissioner of Town and Country Planning for sanctioning of a fund of Rs.30.40 crore under Infrastructure and Amenities Fund:

Replacement of causeway with a high level bridge across river Vaigai near ESI hospital (Aruldasapuram) to Arapalayam	18.00

The Council of Madurai Municipal Corporation has also resolved the above matter vide its Resolution No.471 dated.04.09.2013.

2. The Commissioner, Madurai Municipal Corporation has stated that the proposal is based on the recommendation made in the Comprehensive Mobility Plan prepared for Madurai. In view of the financial constraints of the Corporation he has requested the grant under Infrastructure and Amenities Fund.

3. The District Collector, Madurai has recommended the above proposal to the Commissioner of Town and Country Planning and stated that the low level causeway across the river Vaigai was constructed in the year 1996 by using RCC Hume pipes and it was not designed to cater to the present day traffic flow in the area, which has increased manifold. It is very much necessary to replace this causeway with a high level bridge constructed with concrete pillars. It is also necessary in view of the strong flow of water in Vaigai River during rainy season as the causeway gets submerged due to flood. During that season, this causeway has also corroded gradually thereby weakening the structure slowly. As the above proposal is very much needed for the benefit of the people of Madurai, he has requested for sanction of fund under Infrastructure and Amenities Fund.

4. In the letter second read above, the Commissioner of Town and Country Planning has stated that the subject was placed before the Infrastructure and Amenities Promotion Committee meeting held on 17.05.2013, as Agenda No.10 and the Committee decided as follows:

The Committee recommended for sanction of Rs.30.40 crore to Madurai Corporation for construction of high level bridge at Simmakal road to Goripalayam and ESI hospital (Aruldasapuram) to Arapalayam.

The Commissioner of Town and Country Planning has sent the above proposal to the Government for issue of necessary orders.

5. The Government after careful examination accepts the proposal of the Commissioner of Town and Country Planning and accord administration sanction for a sum of Rs.30.40 crore as grant under Infrastructure and
