### ORDER:

In the letter read above, the Commissioner of Municipal Administration has stated that Anakaputhur Municipality is a Second Grade Municipality in Kancheepuram District, has 18 wards with an extent of 4 Sq.Km. The population as per 2011 census is 48002. At present 27 LPCD (1.31MLD) of water is being supplied to the Anakaputhur Municipality through Chennai Metropolitan Water Supply and Sewerage Board (Water Treatment Plant located at Chembarambakkam). These schemes were formulated considering the population at that time and pipelines were laid few decades back leading to heavy loss of water in distribution. Hence, in order to cater to the needs of the present population for supply of 135 LPCD (13.50 MLD) and to reduce Non-Revenue water (NRW) in distribution, Water Supply Improvement Scheme is essential for Anakaputhur Municipality.

2. The Commissioner of Municipal Administration has stated that Detailed Project Report has been prepared by the consultant at a cost of Rs.1471.54 lakh and the same was placed before the 130<sup>th</sup> Central Sanctioning and Monitoring Committee Meeting held on 12.08.2013 and the project was approved at a cost of Rs.1356.56 lakh with the following funding pattern:-

The above Detailed Project Report has been revised adopting Schedule of Rates for the year 2014-15. The revised cost for the above project has been worked out at Rs.1487.63 lakh, the annual maintenance cost being Rs.254.21 lakh. The additional amount of Rs.131.07 lakh has to be borne by the Urban Local Body.
