ORDER:-

In order to improve the functioning of civic administration and for achieving greater efficiency in its performance, orders were issued in the Government Order first read above for establishment of Tamil Nadu Institute of Urban Studies; Coimbatore. The Institute was permitted to collect the annual contribution from the Urban Local Bodies to run its administration on the Government Order second read above, the quantum of annual contribution was revised in accordance with the grades of the Urban Local Bodies with effect from the year 1987 - 88. In the Government Order third read above, the Government further revised the quantum of annual contribution to be collected from the Urban Local Bodies by the Tamil Nadu Institute of Urban Studies, Coimbatore and the revised rates were fixed as follows with effect from 1995 - 96.

- The Director of Municipal Administration has also sent proposals for the enhancement of rates of annual contribution to be collected from the Corporations and Municipalities by Tamil Nadu Institute of Urban Studies. Coimbatore as resolved by the Management Committee mentioned at para 2 above.
- 5. In this connection, a meeting was convened by the Secretary to Government on 21.04.2009 with the Director of Municipal Administration, the Director of Town Panchayats and the Director, Tamil Nadu Institute of Urban Studies, Coimbatore to arrive at a decision on the rates of annual contribution to be collected from the Urban Local Bodies by the Tamil Nadu Institute of Urban Studies, Coimbatore taking into account all aspects in this regard including the utility factors, financial viability and the development of the Tamil Nadu Institute of Urban Studies, Coimbatore.

- 6. In the above said meeting it was impressed upon all the perticipents that all out efforts should be made to make the Tamil Nadu institute of Urban Studies, Coimbetore a premier institution and a centre of excellence in matters of Urban Studies, Solid and Liquid Waste Management & Urban planning and Research.
- 7. In order to achieve the above objectives, it is necessary that the Tamil Nadu Institute of Urban Studies, Coimbatore is provided with adequate financial resources. After detailed discussions, it was decided during the meeting that the quantum of annual contribution to be collected from the Corporations, Municipalities & Town Panchayats by the Tamil Nadu Institute of Urban Studies, Coimbatore be fixed as follows:-
