In the first meeting of State Urban Development Agency (SUDA) held on 16.9/2004 under the Chairpersonship of the Secretary-to Government, Municipal Administration and Water Supply Department, a decision was taken to provide reasonable marketing avenues for the products produced by the Self Helf Groups (SHGs) and groups formed under the SJSRY in urban areas in supply the self-the groups to the groups t

- 2. Based on the decision, the Commissioner of Municipal Administration in his letter read above has requested the Government to permit Urban Local Bodies to allot shops to Self Helf Groups at nominal rent in Municipal Markets, shopping complexes. Bus stands and other prominent places. The Commissioner of Municipal Administration has also suggested that the nominal rent fixed for the shops allotted to Self Help Groups may be got approved by the Regional Directors of Municipal Administration concerned.
 - 3. The Government have examined the proposal of the Commissioner of Municipal Administration on para 2 above. Accordingly, the Government have permitted the attorment of shops to Self Helf Groups in municipal areas. Such allotments shall be done only with the prior clearance of the Commissioner of Municipal Administration and the number of such allotment in any Municipality shall not exceed 2 or 3. The Commissioner of Municipal Administration shall draw up guidelines for determining the rent / lease amout to be paid by such groups and shall fix the amount in each case.
