ORDER:

In the Government Order first read above, the Government have enhanced the monetary limit to accord Administrative Sanction for the estimate cost of Civil works to be taken up by the Municipalities as follows:-

2. The Director of Municipal Administration in his letter second read above has informed that the Urban Local Bodies are taking up major projects such as under ground drainage scheme, water supply scheme, solid waste management, special road works, bus stands, modernized gasifier crematorium, modernized slaughter houses, multi storied parking stands, multi level shopping complexes and markets, office buildings, etc., at a huge estimated costs for providing infrastructure and basic facilities to the public. He has further added that at

present the estimate cost is escalating every year for various reasons such as periodical increase in the cost of material and labour wages etc. If the Administrative Sanction to be accorded is delayed, the project cost is escalated and it will cause the preparation of revised estimate. Moreover, the prevailing powers were delegated five years before and therefore, an enhancement of monetary limit for according Administrative Sanction is absolutely necessary to reduce the time taken for the same.

3. The Director of Municipal Administration has therefore requested the Government to enhance the monetary limit for according Administrative Sanction to the estimate cost of Civil works to be taken up in the Municipalities as detailed below:-

The Government after careful examination of the proposal of the Director of Municipal Administration and taking into the account of inflation between the previsous revision (2009) and the proposed revision (2016), the percentage change in the Wholesale Price Index (WPI) (All Commodities) & Wholesale Price Index (Fuel, Power and Manufactured products) etc., have decided to enhance monetary limit of the Municipalities for according Administrative Sanction to the estimate cost of Civil works to be taken up in the Municipalities as below:-
