The Government after careful consideration of the request sanction and release the amount of Rs.2124.00 lakhs sanctioned by Government of India share as second installment and corresponding State share of Rs. 1911.59 lakhs to totaling Rs. 4035.59 lakhs for Amman kulam Coimbatore TNSCB, Ukkadam, Coimbatore Tamilnadu Slum Clearance Board (TNSCB), Periyar Nagar, Madurai Tamilnadu Slum Clearance Board (TNSCB), Chennai Corporaati on (phase – II) towards Basic Services for the Urban Poor Scheme (BSUP) .

6.The Director of Municipal Administration is authorized to draw the amount by means of cheque to be drawn in favour of Director of Municipal Administration Basic Services to the Urban Poor Account No: 30120509278 so as to release the amount to the above mentioned Implementing Agencies. The amount would be released from Basic Services to the Urban Poor account only after obtaining Administrative Sanction from the competent authority.
